He sold the business to Stanhope Capital LLP in 2011, where he became a partner and Head of Stanhope Jewson.

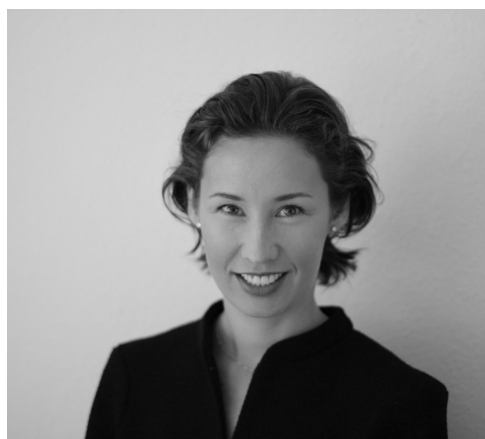
